



## **BACKGROUND AND SCOPE**

The Correctional Medical Authority (CMA) is required, per § 945.6031(2) F.S., to conduct triennial surveys of the physical and mental health care systems at each correctional institution and report survey findings to the Secretary of Corrections. The process is designed to assess whether inmates in Florida Department of Corrections (FDC) institutions can access medical, dental, and mental health care and to evaluate the clinical adequacy of the resulting care.

The goals of institutional surveys are:

- to determine if the physical, dental, and mental health care provided to inmates in all state public and privately operated correctional institutions is consistent with state and federal law, conforms to standards developed by the CMA, is consistent with the standards of care generally accepted in the professional health care community at large.
- 2) to promote ongoing improvement in the correctional system of health services; and,
- 3) to assist the Department in identifying mechanisms to provide cost effective health care to inmates.

To achieve these goals, specific criteria designed to evaluate inmate care and treatment in terms of effectiveness and fulfillment of statutory responsibility are measured. They include determining whether:

- Inmates have adequate access to medical and dental health screening and evaluation and to ongoing preventative and primary health care.
- Inmates receive adequate and appropriate mental health screening, evaluation, and classification.
- Inmates receive complete and timely orientation on how to access physical, dental, and mental health services.
- Inmates have adequate access to medical and dental treatment that results in the remission of symptoms or in improved functioning.
- Inmates receive adequate mental health treatment that results in or is consistent with the remission of symptoms, improved functioning relative to their current environment and reintegration into the general prison population as appropriate.
- Inmates receive and benefit from safe and effective medication, laboratory, radiology, and dental practices.
- Inmates have access to timely and appropriate referral and consultation services.
- Psychotropic medication practices are safe and effective.
- Inmates are free from the inappropriate use of restrictive control procedures.
- There is sufficient documentation to provide a clear picture of the inmate's care and treatment.
- There are enough qualified staff to provide adequate treatment.



## **METHODOLOGY**

During a multi-day site visit, the CMA employs a standardized monitoring process to evaluate the quality of physical and mental health services provided at this institution, identify significant deficiencies in care and treatment, and assess institutional compliance with FDC's policies and procedures.

This process consists of:

- Information gathering prior to monitoring visit (Pre-survey Questionnaire)
- On-site review of clinical records and administrative documentation
- Institutional tour
- Inmate and staff interviews

The CMA contracts with a variety of licensed community and public health care practitioners including physicians, psychiatrists, dentists, nurses, psychologists, and other licensed mental health professionals to conduct these surveys. CMA surveyors utilize uniform survey tools, based on FDC's Office of Health Services (OHS) policies and community health care standards, to evaluate specific areas of physical and mental health care service delivery. These tools assess compliance with commonly accepted policies and practices of medical record documentation.

The CMA employs a record selection methodology using the Raosoft Calculation method. This method ensures a 15 percent margin of error and an 80 percent confidence level. Records are selected in accordance with the size of the clinic or assessment area being evaluated.

Compliance scores are calculated by dividing the sum of all yes responses by the sum of all yes and no responses (*rating achieved/possible rating*) and are expressed as a percentage. Institutional tours and systems evaluations are scored as compliant or non-compliant. Individual screens with a compliance percentage below 80%, as well as tour and systems requirements deemed non-compliant will require completion of the CMA's corrective action process (CAP) and are highlighted in red.



## INSTITUTIONAL DEMOGRAPHICS AND STAFFING

Taylor Correctional Institution (TAYCI) houses male inmates of minimum, medium, and close custody levels. The facility grades are medical (M) grades 1, 2, 3, 4 and 5, and psychology (S) grades 1 and 2. TAYCI consists of a Main Unit as the Annex is currently closed.<sup>1</sup>

Screen 1: In six records, the periodic screening was completed more than one year after it was due. In three records, the screenings were completed approximately six to nine months after they were due. In the remaining record, the periodic screening was completed two years after the due date.

Screen 2: In 12 records, weight and/or vital signs comparison to the inmates' prior data was missing. In three of these records, there was no evidence that the inmate was given lab results in addition to the missing weight and/or vital signs comparison. In one record, the inmate was not given lab results and a tuberculosis screening was not completed. In another record, weight and/or vital sign comparison was missing, and an abnormal urinalysis was not addressed. In the next record, weight and/or vital sign comparison was missing, and the inmate was not oriented to all spheres without further evaluation. In the last record, an inmate did not have an EKG ordered as was indicated for multiple medical comorbidities.

Screen 3: In four records, a fasting plasma glucose (FPG) level was missing. In three records, there was no evidence of FPG levels in addition to the fecal occult blood test (FOBT). In two records, the prostate-specific antigen (PSA) was not completed in addition to the FPG and FOBT. In one record, there was no evidence of the FOBT and a CT indicated for those with an applicable smoking history. In the last record, there was no evidence of the required urinalysis.

Screen 4: In two records, abnormal urinalysis findings were not relayed to the doctor for further evaluation. In one record, an inmate with a change in cognitive orientation and vision was not referred to the clinician.

Screen 6: In one record, laboratory testing was not documented. In the second record, initial laboratory testing was completed following the PREA incident; however, there was no evidence that repeat testing occurred as indicated.

Screen 7: In four records, the referral from physical health staff erroneously indicated that mental health staff had seven days to interview the inmate. Department policy requires that this evaluation be completed the next working day.

Screen 9: In this record, an inmate with a history of mental health treatment including psychotropic medication, requested further treatment after a PREA incident. He allegedly was held at knife point and required to perform oral sex on another inmate. Documentation did not include a referral to psychiatry or a clinical rationale as to why the inmate was not referred. Additionally, the clinician wrote that no follow-up was indicated, and the inmate did not receive the therapy or counseling services he requested.

## **Interview Summaries**

#### **INMATE INTERVIEWS**

Twelve inmates agreed to participate in interviews. Overall, inmates were complementary of medical services and indicated that sick call and emergency care was administered timely. Inmates denied difficulty in obtaining medication for physical health needs. Several inmates reported that they have medical issues that are not being addressed. Inmates reported long wait times for the preventative dental plan but were satisfied with these services once they were initiated.

Overall, inmates expressed satisfaction with mental health services and were particularly complementary of the mental health professional (MHP). They indicated that individualized treatment has been beneficial in helping them adjust to the prison environment. Several inmates reported that wait times for psychiatric consultations have been long.

#### **MEDICAL STAFF INTERVIEWS**

Five members of the medical team participated in interviews. All were knowledgeable about policies and procedures directing the provision of health care at this institution. Staff was aware of emergency plans and reported that security staff is cooperative and helpful when assistance is required. Most interviewees indicated that they needed new equipment, specifically a stretcher, and more consistent internet access.

#### MENTAL HEALTH STAFF INTERVIEWS

There is one MHP position at Taylor CI; however, staff was out on military leave. Coverage was provided by counselors from neighboring institutions, but none were on-site during the survey; therefore, no one was available to interview.

#### SECURITY STAFF INTERVIEWS

Three correctional officers were interviewed. Security staff appeared knowledgeable about policies pertaining to the sick call process and the accessing of emergency and routine medical care. They correctly verbalized procedures that pertain to inmates being placed in special housing. They described a good working relationship with medical and mental health staff.

All items that scored below 80% or were identified as non-compliant should be addressed through the corrective action process. Within 30 days of receiving the final copy of the CMA's survey report, institutional staff must develop a corrective action plan (CAP) that addresses the deficiencies outlined in the report and in-service training should be conducted for all applicable findings. The CAP is then submitted to the Office of Health Services (OHS) for approval before it is reviewed and approved by CMA staff. Once approved, institutional staff implement the CAP and work towards correcting the findings.

Usually, four to five months after a CAP is implemented (but no less than three months) the CMA will evaluate the effectiveness of the corrective actions taken. Findings deemed corrected are closed and monitoring is no longer required. Conversely, findings not corrected remain open. Institutional staff will continue to monitor open findings until the next assessment is conducted, typically within three to four months. This process continues until all findings are closed.

#### Recommendations

In addition to the needed corrective actions described above and based upon the comprehensive review of the physical, mental health, and administrative services at TAYCI, the CMA makes the following recommendations:

- Retrain nursing staff on policies and procedures associated with the provision of periodic screenings.
- Ensure that nursing staff is appropriately trained on how to respond to PREA incidents.
- Ensure that inmates enrolled in the endocrine clinic receive the necessary specialized care.
